# Important information for claiming weekly benefits due to the coronavirus emergency معلومات هامة للإعانات الأسبوعية بسبب حالة الطوارئ الخاصة بفيروس كورونا

In order for us to process your weekly payment without delay, please follow the below guidelines when certifying for your benefits each week.

#### Question 1 - Were you able and available for work?

Unless you are too physically ill to work, the answer to this question should be **YES**. If you are out of work temporarily due to a closure related to the Coronavirus and expect to return to your job, say **YES** to this question.

#### Question 2 - Were you actively seeking work?

#### Question 4 - Were you attending school or job training?
